

Step 1: 3 ways to get to the AGENDA webpage:




Option 1. From a browser go to: <http://www.ontariohomicide.ca/agenda.html>

Follow one of the Step 1 options to get to the Agenda page, then follow this:




Interactive Agenda

3. Select **Add by URL** from the menu
4. Enter the URL: webcal://tockify.com/api/feeds/ics/sean.ramitt in the field provided
5. Click the **Add Calendar** button. The calendar will appear in the **Other Calendars** section of the calendar list to the left.
